



Waste and Site Operations

MPPB Deconstruction Waste Support

(as of the end of March 10)

- Shipped a total of 1,290 intermodals or 215 rail cars of debris (25,115 tons)
- Shipped a total of 87 Specialty Boxes removed from the MPPB Deconstruction Project (805 tons)
- Continue to receive and prepare boxes



Waste and Site Operations (Cont.)

Waste Tank Farm:

- Previously, overpacked one Waste Tank
 Farm pump (SP-339) that was shipped on October 30, 2024
 - Overpacked two other pumps into SP-340 and SP-341 in December 2024
 - Overpack fourth pump, SP-108, into SP-372 in March 2025
 - Two pumps are scheduled to ship the week of March 24, the last one will ship in early April



Waste and Site Operations (Cont.)

Tank 8D-4 Work:

- 8D4 sludge sampling is completed
- Five(5) samples packaged and shipped to the lab for analysis
- Completed the removal of the camera and waste, and stored the system for possible future work
- Working on possible paths forward to safely and compliantly disposition this waste
